Terms and Conditions for Videography / Photography Services

Effective for 2025

These terms and conditions outline the policies and practices of Jayden Lampasi Films ("Videographer / Photographer") regarding the provision of services in the United Kingdom, Europe & Australia. By engaging the Videographer / Photographer, clients acknowledge and agree to these terms and conditions.

1. General Policies

- All services are provided in accordance with these terms. Any changes to these terms will be communicated and mutually agreed upon.
 - Jayden Lampasi Films operates independently. Third parties may not impose agency fees unless discussed and agreed upon in advance.
 - Jayden Lampasi Films will not be subject to non-compete clauses in any form.

2. Booking, Payment, and Cancellation

Booking and Payment

- A booking is confirmed upon agreement of terms via email/WhatsApp/Instagram/call or any other form of written online communication.
- No deposit is required for services with Jayden Lampasi Films.
- The balance is to be paid within 14 days of receipt of the invoice, unless otherwise agreed upon. Late fees of 2% per day shall be applied to overdue invoices.
- In case of rescheduling, Jayden Lampasi Films will make reasonable efforts to accommodate a new date, subject to availability, without additional charges if the request is made more than 2 weeks before the original session date.

Cancellation Policy

- Cancellations made:
 - **7 days or less** before the scheduled session will be charged **100%** of the agreed fee.
 - **2 weeks or less** before the scheduled session will be charged **50%** of the agreed fee.
 - Cancellations made more than **2 weeks** before the scheduled session will not incur charges.

3. Copyright and Media Usage

- All media produced by Jayden Lampasi Films remain the Videographer / Photographer's intellectual property.
- Clients are granted a license to use the images for personal, & non-commercial purposes unless otherwise agreed upon in writing.
- Images / Videos may not be altered, cropped, or edited without permission from Jayden Lampasi Films.

- Images may not be shared unedited. Non-compliance or unwillingness to alter credits, will result in a £500 penalty.

4. Jayden Lampasi Films Use of Media

- Jayden Lampasi Films reserves the right to use media for portfolio purposes (inclusive of social media), promotional content, competitions, exhibitions.

5. Client Responsibilities

- Clients are responsible for providing accurate session details, including location and special requirements.
 - Necessary permissions, such as property releases or permits, must be secured by the client.
 - Jayden Lampasi Films is not responsible for issues arising from a lack of required permissions.

6. Delivery of Media

- Edited media will be delivered via an agreed upon timeline.
 - A next day preview can be sent for an additional £50
 - Media will be delivered via dropbox that will be online for 3 months. After this, it is the responsibility of the client to safekeep all media.

7. Limitations of Liability

- In the event of equipment failure or other unforeseen circumstances beyond the control of Jayden Lampasi Films, a partial refund or discount may be offered to the client, depending on the extent of the impact on the final product. The amount of the refund or discount will be determined at the discretion of Jayden Lampasi Films.
- In cases where services cannot be delivered, Jayden Lampasi Films' liability is limited to the amount paid by the client.
- Jayden Lampasi Films is not liable for disruptions due to weather conditions, acts of God, or other force majeure events. Jayden Lampasi Films is to be paid in line with their cancellation policy.
- 3 months after the delivery of media, Jayden Lampasi Films retains the right to delete original files. While Jayden Lampasi Films aims to store as many projects as possible, It is the responsibility of the client to safekeep all delivered media and Jayden Lampasi Films is not liable for any lost data past 3 months.

8. Privacy and Data Protection

- Personal data is handled in compliance with the General Data Protection Regulation (GDPR).
 - Client information is not shared with third parties.

9. Governing Law

- These terms are governed by the laws of the United Kingdom & Australia.

10. Social Media and Image Credit

- Clients are required to tag @lvmpasi in any social media posts that feature media captured by Jayden Lampasi Films.
- All media produced by Jayden Lampasi Films are licensed under copyright. If an image / video is to be used for any commercial purposes or without the appropriate credit, a buyout of the media must be made. The buyout fee will be determined based on the intended use of the media.
- The buyout fee will be determined based on the scope, duration, and intended commercial use of the image / video. Fees start at £150 and vary according to publication and presses.

- By booking media services with **Jayden Lampasi Films**, clients confirm that they have read, understood, and agree to these terms and conditions in full.
